The applicants for planning application 2023/0048/LBC (item 10a) were in attendance and spoke about the submitted plans.

The question was raised again concerning the public toilets in Wells, Cllr Ros Wyke responded the matter would be chased again. The subject of buses was also discussed and whether they would continue after the subsidy from Somerset County Council finishes in April.

Grit needs replacing within the grit bins within the village due to usage over the recent cold weather. This will be added to the agenda for the next meeting.

County Councillor Heather Shearer sent her apologies

District Councillor Ros Wyke was in attendance and gave a verbal report covering subjects such as formal events being held to mark the end of Mendip District Council, Mental Health and Well Being including the installation of talking benches and Men's Sheds. Various Grants are available and information can be found on the Mendip District Council website.

County Councillor Ros Wyke was in attendance and gave a verbal report covering subjects as to how planning may work within the new unitary council and the new cycle and pathways currently being installed across the area. The Local Community Networks were raised and the Council were informed that Westbury Sub Mendip is with Wells and St Cuthberts Out.

 - (a) 2023/0048/LBC Installation of two small solar PV arrays on two outbuildings. Old Ditch Farm, Lynch Lane, Westbury Sub Mendip

 Update Westbury Sub Mendip Parish Council recommended approval as they supported environmentally and friendly source of electricity. There would be no change to the landscape and the panels will not really be visible.
 - (b) 2023/0037/TCA T1 Quince Fell, T2 English Elm Fell. Dags Hole, Old Ditch, Westbury Sub Mendip **Update** Westbury Sub Mendip Parish Council recommended approval The Parish Council noted that a replacement tree for the quince was intended. They agreed that it would encourage the practice planting of a replacement tree when damaged ones are felled.
